The Danish Maritime Fund

- A commercial fund established in 2005
- The purpose is to provide financial support to initiatives enabling growth and innovation in the Danish maritime sector
- The means of the Fund derive from dividends from the 10% share of Danish Ship Finance



The donation policy

The maritime sector - The Blue Denmark - comprises 25% of Danish export and is thus the highest yielding export sector. We are globally the 5th largest shipping nation and the 7th largest maritime industrial nation. Only Danish entities and institutions are eligible. Our donations and loans shall:

- Support 'The Blue Denmark' by means of non-profit grants or loans for early engagement funding
- Be of instant value to Danish shipping companies, shippards and manufacturers of maritime equipment
- Support innovative and future-oriented initiatives
- Have a catalytical effect and create new jobs
- Support maritime activities, that support/can be linked to one or more of UN's 17 SDGs



Our categories of funding

- Maritime commercial projects soft funding
- Maritime sector development (conferences, campaigns, political initiatives) grant
- Development of maritime education and recruitment initiatives grant
- Maritime research grant
- Maritime competence development scholarships



We act as incubators for a substantial number of projects

- Over the years, we have supported over 900 projects of which two thirds are non-profit and remaining are soft funding of commercial projects
- Grants since founding comprise over DKK 750 mill
- Grants and soft funding make up for:
 - Maritime commercial projects
 Maritime sector development
 Development of maritime education / recruitment initiatives
 Maritime research
 Maritime competence development



Non-profit projects

- Donation covering directly related project costs
- Creating basis for broad knowledge sharing
- Within applied research, competence development, education, campaigns and conferences



Commercial projects

- Soft funding of up to 50% of the project budget at 0 pct. interest
- After a grace period of 3-5 years repayment of the loan over a similar period (fixed payment schedule)
- Soft funding is typically provided as early stage funding to start-ups, but can also be offered to scale-ups or as co-funding of innovation projects in corporations



Grants to support maritime research

We have donated about DKK 200 mill. kr. to Danish maritime research

- Universities (DTU, CBS, KU, ITU, SDU, AU, AAU, RUC)
- Maritime and business schools
- Companies and organisations



Grants to support education, competence development and recruitment

We have donated over DKK 215 mill. kr. to education and recruitment

- Development of education programmes (universities, maritime schools, etc)
- Scholarships to MBA and shipping diploma studies
- Worldcareers.dk



Financing provided to commercial projects via loans on special terms comprise about DKK 200 mill. (27%)
